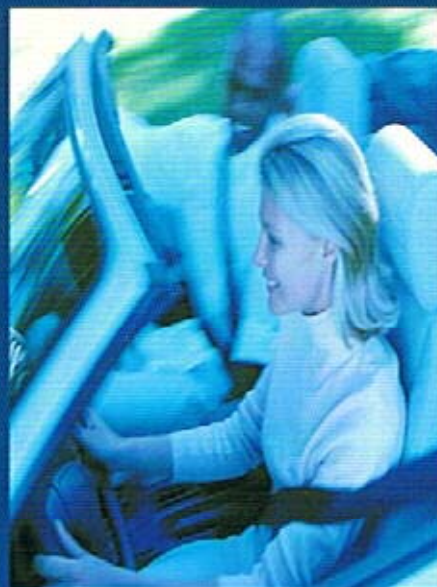

## *mechanical protection for new & pre-owned vehicles*

Congratulations on the purchase of your vehicle. You've just made one of the single largest purchases in your life and you now have the opportunity to protect it.

First Automotive's vehicle service contracts provide continued mechanical breakdown protection for the long road of ownership ahead. You can be protected from the high cost of unexpected mechanical breakdowns and component failures.

Everyone has experienced or witnessed an unexpected vehicle breakdown. These are always inconvenient and expensive unless you have protection from a vehicle service contract from First Automotive. A mechanical protection plan from First Automotive is an intelligent decision to protect you from the increasingly high cost of automotive mechanical breakdowns.

## *vehicle service contracts include vehicle protection*

First Automotive pays for the costs of parts and labor during the repair or replacement of major component parts.

### *national acceptance*

First Automotive contracts are accepted by repair facilities nationwide. In the event that a network repair facility is not available, transient claims are paid by a First Automotive credit card.

### *rental reimbursement*

If you are in need of a rental vehicle during a mechanical failure, due to covered repair work, First Automotive will allow rental coverage with no deductible.

### *towing coverage*

The First Automotive plan provides for towing reimbursement when in conjunction with the repair of a covered item.

### *increased resale value*

If you sell your vehicle, the remaining First Automotive coverage can be transferred to the new owner, allowing you the possibility of a higher resale price.

### *roadside assistance*

If you need assistance when you are on the road, call us for an emergency supply of gasoline and fluids, towing, flat tire and lock out assistance, or battery jump start.

## *schedule of coverage comprehensive*

This Agreement will cover necessary repairs to ALL of your vehicle's mechanical and electrical parts, except for those items listed below.\*

### *\*COMPONENTS NOT COVERED by comprehensive coverage:*

*Service adjustments/cleaning; battery/cables, belts; hoses; brakes (front hub, drums, shoes, lining, disc rotors and pads); coolant; exhaust systems (including catalytic converter); lights, (bulbs, sealed beam and lenses); filters, fluids, lubricants, manual clutch disc, shock absorbers, spark plugs/wires; squeaks and rattles, tires, tune-ups, wheel balancing, wheel alignment, wheel studs, wiper blades; service adjustments (glass and body parts); bright metal, bumpers, glass, moldings, ornamentation, paint, rust, sheet metal; sideview mirrors (glass, housing); water leaks, weatherstrip; wheel covers/ornaments; wind noise; interior buttons, carpet, dash pad, window handles, interior knobs; rearview mirror (glass, housing); interior trim, upholstery. ## *additional benefits*

### **TOWING:**

*In the event of a mechanical breakdown caused by a part covered by this Contract, we will reimburse you for reasonable towing charges up to eighty dollars (\$80) per occurrence.*

### **RENTAL CAR:**

*In the event of a mechanical breakdown caused by a part covered by this Contract, rental car reimbursement, from a licensed rental agency, will be provided to you on the basis of thirty dollars (\$30) for every eight (8) hours, or portion thereof, of applicable labor time required to complete the covered repair, up to a maximum of one hundred and fifty dollars (\$150) for each occurrence.*
